Executive Summary

Throughout this quarter (1/Mar/ 2015—30/June / 2015), 19 women and 11 children have stayed at Daikundi Women Protection Center (WPC). Of these, 7 women had Legal cases and 12 others had criminal cases. From these 11 children, mothers of 2 children who are 13 and 8 years old and living in WPC are in jail, and 9 children were in the WPC with their mother. LSO protected and have done for these women all required services (psycho-socio counseling, legal advice, access to justice to victims of gender based violence, etc.) During this quarter, they became capable to challenge any basic risk in the society or environment of works).

In addition to providing shelter, social protection services, and access to justice to victims of gender based violence, LSO's social workers carried out regular follow-ups with the clients, and its staff continued to meet with local officials and stakeholders to introduce LSO and advocacy for women's rights.

As LSO could solve the problems of 16 women who were at risk by solving their legal and criminal cases in courts and attorney and delivered them to their families and they entered into the follow-ups stage, but 3cases remained still in progress stage. So far, according to LSO's follow-ups, they have been being happy and living with their families peacefully. They say that no one has caused violence against them from the time when they came back their home. This is a big achievement that LSO has received at this quarter.

The main objectives of project:

- 1. Provide women protection center (WPC) for women at risk of violence in Daikundi province.
- 2. Providing women at risk of violence with comprehensive psychological and physical support, and safety in the mentioned location.
- 3- Providing women at risk of violence with access to justice through advocacy.
- 4- Rehabilitation of their psychological and physical health through psycho-social counseling and law services in their lives problems.

LSO has gotten some result during of the project in the Daikindi province according the WPC's regulations and the most important result is:

1. At this Quarter 16 clients were reintegrated to their family, and their problems were solved, social workers started their follow ups from every case both via calling and meeting their family.

For abovementioned result, LSO performed the following services and activities for them:

- 1. Accommodation for clients, accompanying them, Provision of food and drink, sport materials, cleaning and hygiene supplies.
- 2. All beneficiaries benefited from the literacy, numeracy classes of different levels, Provision of library, and Awareness raising sessions. The awareness sessions were about basic health care, childcare, women's rights, and Sharia law.
- 5. A full time nurse has done the daily check-up of the beneficiaries, the necessary services, but urgent ill and patients referred to the nearest health facility (PH) for proper treatment and medication.
- 6. Vocational trainings like embroidery, tailoring and handicrafts were provided for all clients in the WPC.
- 7. On the other hand, LSO facilitate the situation for personnel to participate in Capacity building training on Elimination of Violence against Women.
- 8. Transportation services were provided for clients and accompanying personnel to pick them up from WPC and transport to related government offices; DoWA, courts, attorney's office, and hospital, and took them back to the center. As well as transportation picked up and dropped the project staff and logistical arrangements of the WPC.

Interesting and Marvelous Stories of Pary Gul daughter of Saeed Mahboob

Pary Gul who lives in Kesaw village, Kitee district of Daikundi Province was raped in her village. She has mental problem and became unconscious (Epilepsy) on and off. Her family tried to cure her by magic and they wanted a mullah, Mohammad son of Awaz, from another district of Daikundi province. Mullah came to Kitee disctrict on 27/5/2015. Mullah asked other members of family to leave Pary Gul and him alone at home for some minutes. Then, He started to do to the action of rape on her, but she screamed very aloud and her mother entered home to see what happen. Her mother saw that Mullah was doing this illegal action. Her mother referred local governments for advocacy of her daughter and jailing Mullah. Government sent her to AIHRC and Pray Gul was referred to Daikundi's WPC. Fortunately, Mullah was arrested and jailed in Daikundi province and his case is currently under process.
